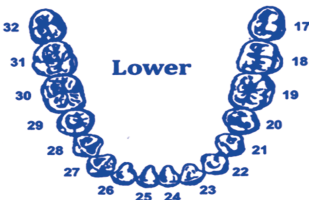

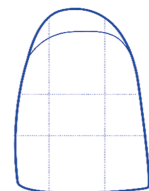

EACH PRESCRIPTION MUST BE COMPLETED AND SIGNED DOCTOR WILL BE RESPONSIBLE FOR COSTS RELATED TO THE RECOVERY OF BALANCES OWED IN CASE OF COLLECTION, THIS MAY INCLUDE LEGAL FEES INCURED.

No-Fault Remake Policy, Limited Warranty, and Zirconia 7 years Performance Warranty/Replacement Policy

No-Fault Remake Policy

American Dental Designs is pleased to process all remakes or adjustments of the below-identified devices manufactured by American Dental Designs at no additional charge if requested within the warranty period and accompanied by the return of the original case, as described in further detail below. The device can be exempted from returning up to 3 units of ceramic restoration products. American Dental Designs can cancel, change, or alter this policy at any time.

LIMITED WARRANTY AND ZIRCONIA 7 YEARS PERFORMANCE WARRANTY/REPLACEMENT POLICY/LIMITATION OF LIABILITY, American Dental Designs ("the lab") warrants that all dental devices (a "device") are made according to your specification and approval in the belief that the device will be useful and MAKES NO OTHER WARRANTIES INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE EXCEPT AS OTHERWISE EXPLAINED IN THE ZIRCONIA 7 YEARS PERFORMANCE REPLACEMENT POLICY DESCRIBED BELOW. Subject to the return of a device that is placed and then fails, the lab will repair or replace the device without charge for the cost of workmanship, at the lab's option, as follows:

- Zirconia restorations, including restorations over implants, and PFM manufactured by the lab, are warrantied for the seven years of the patient initially receiving the restoration from the date of placement. This limited seven-year performance warranty shall only apply to direct end-user customers (treating clinicians).

- Generic custom implant abutments are warrantied for the seven years of the patient initially receiving the restoration from the date of placement.
- Authentic custom implant abutments are warrantied per the policy set by third party warranty of the authentic implant abutment system.
- The lab manufactures Temporary/Provisional Crowns and Bridges for up to 6 months.
- The denture includes screw-retained dentures but excludes immediate and provisional dentures manufactured by the lab for up to 1 year if the failure is due to defects in materials or workmanship. It does not cover denture reline after 30 days.
- Thermoformed appliances, thermoformed splints, and the Comfort3D Bite Splint if the failure is due to defects in materials or workmanship, composite resin, Maryland and inlay/onlay bridges, flippers, manufactured by the lab up to 6 months.
- Provisional implant prosthesis manufactured by the lab for up to 60 days.
- Immediate and provisional dentures, partials, retainers, prosthetic stents, surgical guides, radiographic guides, and all other dental devices manufactured by the lab for up to 30 days if the failure is due to defects in materials or workmanship. It does not cover denture reline.

This warranty is exclusively for your benefit, is not transferable, and does not extend to any patients. You agree to pay all other costs of adjustment, repair and replacement of a device. Except where prohibited by law, the lab WILL NOT BE LIABLE FOR ANY LOSS OR DAMAGES ARISING FROM THE USE OF A DEVICE. WHETHER DIRECT, INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL, regardless of the theory asserted, including warranty, contract, negligence or strict liability and if such disclaimer is not permitted by law, the duration of any implied warranty is limited to 90 days from the date of delivery. In the event of a dispute the parties agree to waive class actions in favor of mandatory individual arbitration of claims under this limited warranty in and in accordance with the laws of Pennsylvania. The lab does not guarantee the performance of independent carriers.
